

COSMOS PERFORMANCE COSMOS DIESEL ASSISTANT APPLICATION
SOFTWARE LICENSE AGREEMENT

BY PURCHASING, DOWNLOADING, INSTALLING, OR USING THE COSMOS PERFORMANCE COSMOS DIESEL ASSISTANT APPLICATION, YOU AGREE TO BE SUBJECT TO THIS COSMOS PERFORMANCE SOFTWARE END USER LICENSE AGREEMENT (“LICENSE”) AND TO BE BOUND BY ALL OF ITS TERMS CONTAINED HEREIN. IF YOU DO NOT AGREE TO THE TERMS OF THE LICENSE, DO NOT PURCHASE, DOWNLOAD, INSTALL, OR USE THIS APPLICATION.

1. **LICENSE GRANT.** Cosmos Performance hereby grants you the following rights provided that you comply with all terms and conditions of this License: You are granted a nonexclusive license to use Cosmos Performance’s Software contained in the Cosmos Diesel Assistant Application product that you purchased (“the Software”) for the sole purpose of operating the purchased Cosmos Diesel Assistant Application (the “Product”). The Software refers to the software that is stored in the Cosmos Diesel Assistant Application. The Software may not be separated from the Product, in whole or in part, for use on more than one Product or other device. The Software includes trade secrets and/or proprietary information, including trade secrets and/or proprietary information that may have been licensed to Cosmos Performance by third parties, and the following prohibitions herein, including the prohibition on reverse engineering, include and apply to any and all such third-party content. Cosmos Performance and any of its licensors maintain ownership of the Software, information generated by the Software, and any and all related materials, and reserve all rights not expressly granted to you.

1.1. You have no rights to any source code or object code for the Software. You shall not, or cause or permit, directly or indirectly the modification, disassembly, recompilation, or reverse engineering of the Software, in whole or in part, or otherwise attempt to gain access to the source code to the Software. You agree not to create derivative works or cause or permit others, directly or indirectly, to create derivative works based upon the Software. Except as otherwise provided for herein, you may not distribute, rent, lease, sell, license, or otherwise transfer rights in the Software, or information generated by or used by the Software, to any other person or entity or make any other commercial use of the Software or the information generated by or used by the Software for financial or other form of gain.

1.2 You must retain all copyright and trademark notices on the Software and Product and take reasonable steps to protect Cosmos Performance’s and any of its licensor’s intellectual property rights. This License does not transfer any ownership rights in the Software or any related materials to you or to any third party.

2. **WARRANTY.** Cosmos Performance warrants that it is the owner of the Software or has the right to grant the license described in this License without violating the rights of any

third party and the media containing the Software shall be free from defects for a period of thirty (30) days from the date of purchase of the Software.

3. **DISCLAIMER.** TO THE MAXIMUM EXTENT ALLOWED BY LAW, THE WARRANTIES IN PARAGRAPH 2 ARE IN LIEU OF, AND THIS LICENSE EXPRESSLY EXCLUDES, ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, ORAL OR WRITTEN, INCLUDING, WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

4. **LIMITATION OF LIABILITY.** TO THE MAXIMUM EXTENT ALLOWED BY LAW, COSMOS PERFORMANCE IS NOT LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES, INCLUDING THE LOSS OF PROFITS, REVENUE, DATA, OR USE OR COST OF SUBSTITUTE GOODS INCURRED BY YOU OR ANY THIRD PARTY, WHETHER IN AN ACTION IN CONTRACT OR TORT OR BASED ON A WARRANTY, EVEN IF COSMOS PERFORMANCE OR ANY OTHER PERSON HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

5. **TERMINATION.** This License shall terminate automatically if you fail to comply with the limitations described above. You may terminate this License at any time. In the event of termination, you agree to stop using the Software and the Product, and to destroy the Software and Product.

6. **EXPORT CONTROLS.** None of the Software or underlying information or technology may be downloaded, exported, or re-exported into any country to which the United States ("U.S.") has embargoed goods, or to anyone on the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Commerce Department's Table of Deny Orders. By using the Software, you are agreeing to the foregoing and you are representing and warranting that you are not a national or resident of, or located in or under the control of, any country subject to such export controls.

7. **UPDATES.** Cosmos Performance and any of its licensors have no obligation to provide updates, bug fixes or error correction.

8. **TRANSFER.** You may transfer this License and the rights to the Software granted herein to any third party with the transfer of the corresponding Product containing the licensed Software (retaining nothing). The transferee receiving the Product including the Software receives the Product subject to all of the terms in this License.

9. **MISCELLANEOUS.** This License represents the complete agreement between the parties concerning the Software and this License and supersedes any and all prior agreements or representations. This License may only be amended by a writing executed by both parties. If any provision of this License is held to be unenforceable for any reason, such provision shall be reformed only to the extent necessary to make it enforceable. This License shall be governed by and construed under Utah law without reference to it

principles of conflicts of law. At Cosmos Performance's sole discretion, the parties consent to the exclusive jurisdiction and venue in any Utah State or Federal Court of competent jurisdiction located in the central region of Utah. Should a dispute arise out of the enforcement of this License, the prevailing party shall be entitled to an award of its reasonable costs and attorney's fees in addition to any other damages or other awards ordered by the court. Paragraphs 1.1, 1.2, 2-4, and 9 shall survive termination of this License.

10. ACCEPTANCE. By opening the sealed packaging containing the Product and Software, or using the same, I agree to the above terms of this License.
